

ESTIMATED TIME FRAMES*

These are the tentative timelines that we follow for different immigration matters. The actual timeline can considerably change depending upon various factors like delay in submission of documents by clients; delay in communication from other stakeholders including but not limited to: like Immigration New Zealand, Institutions, NZQA, etc..

1. Student Visa Applications

We estimate that this matter will involve the following stages and timeframes:

1	The assessment of your eligibility and issuance of checklist by Us	Within:	5 working days from the date of your enquiry
2	Submission of all the documents as per the checklist by you to our office	Within:	As much Time taken by you
3	Admissions and grant of offer letter		As per the prevailing timelines of the foreign institution
4	Final Checking/Verifying the documents /forms submitted by you to our office	Within:	10 working days from the date of submission of all documents as per the checklist
5	Lodging of Student Visa Application with INZ	Within:	5 working days after Stage 4
6	INZ Process and decision		As per the timelines stipulated by Immigration New Zealand.

We will confirm to You in writing when Your application, request, claim, and/or appeal has been submitted to Immigration New Zealand, and provide You with **ongoing timely updates every 6 weeks or sooner if we receive any information from INZ.**

2. Visitor Visa General / Partnership based Visitor or Work Visas and all other temporary visas other than student visas

We estimate that this matter will involve the following stages and timeframes:

1	The assessment of your eligibility and issuance of checklist by Us	Within:	3 working days from the date of your enquiry
2	Submission of all the documents as per the checklist by you to our office	Within:	As much Time taken by you
3	Final Checking/Verifying the documents /forms submitted by you to our office	Within:	5 working days from the date of submission of all documents as per the checklist
4	Lodging of Visa Application with INZ	Within:	5 working days after Stage 3
5	INZ Process and decision		As per the timelines stipulated by Immigration New Zealand.

We will confirm to You in writing when Your application, request, claim, and/or appeal has been submitted to Immigration New Zealand, and provide You with **ongoing timely updates every 6 weeks or sooner if we receive any information from INZ.**

3. Request to INZ or other departments under the Official Information Act / Privacy Act:

We estimate that this matter will involve the following stages and timeframes:

1	Submission of Request to INZ under the OIA/PA	Within:	3 working days from the date of submitting signed form 1160
2	Receiving the information from INZ		As per the timelines stipulated by Immigration New Zealand.
3	Assessment of the notes/information received from INZ	Within:	7 working days from the receipt of the package at our office
4	Informing you about the future application possibilities	Within:	3 working days from the assessment

We will confirm to You in writing when Your application, request, claim, and/or appeal has been submitted to Immigration New Zealand, and provide You with **ongoing timely updates every 6 weeks. We will inform you sooner if we hear from INZ.**

4. NZQA - International Qualification Assessment

We estimate that this matter will involve the following stages and timeframes:

1	The assessment of your eligibility and issuance of checklist by Us	Within:	3 working days from the date of your enquiry
2	Submission of all the documents as per the checklist by you to our office	Within:	As much Time taken by you
3	Final Checking/Verifying the documents /forms submitted by you to our office	Within:	5 working days from the date of submission of all documents as per the checklist
4	Lodging of IQA Application online with NZQA & Dispatch of physical documents	Within:	5 working days after Stage 3
5	NZQA Process and decision		As per the timelines stipulated by NZQA

We will confirm to You in writing when Your application for IQA has been submitted to NZQA, and provide You with **ongoing timely updates after 35 working days or sooner if we receive any information from NZQA.**

5. Professional Registration with relevant authorities:

We estimate that this matter will involve the following stages and timeframes:

1	The assessment of your eligibility and issuance of checklist by Us	Within:	5 working days from the date of your enquiry
2	Submission of all the documents as per the checklist by you to our office	Within:	As much Time taken by you
3	Final Checking/Verifying the documents /forms submitted by you to our office	Within:	7 working days from the date of submission of all documents as per the checklist
4	Lodging of Registration Application online & Dispatch of physical documents	Within:	5 working days after Stage 3
5	Professional Registration Process and decision		As per the timelines stipulated by the relevant authority.

We will confirm to You in writing when Your application for Professional Registration has been submitted to the relevant authority, and provide You with **ongoing timely updates after 35 working days or sooner if we receive any information from the authorities.**
